# 23-033 MATTERS ARISING FROM THE MINUTES:

J deWit requested to discuss minutes of February 2022 meeting on licence holder surveys. Chair advised the minutes Council were approving were March 2023 and asked Mr deWit to stay within the boundaries of the minutes of the March meeting. Mr deWit continued and the Chair asked Mr deWit to either please be quiet or leave the room. Mr deWit continued on and after a short discussion Mr deWit was advised he could bring his issues up as a notice of motion at the next meeting as his topic is not part of the March minutes. Mr deWit agreed to this.

It was **AGREED** to change the order of the agenda to allow discussion on the CE report to be undertaken earlier in the meeting.

#### 23-034 CHIEF EXECUTIVE'S REPORT:

034.1 Upper Ohau River Spring Season 2022 (8.1)

CE spoke to this report advising that the Upper Ohau is an important destination fishery for many anglers with a high public profile whereby any decision Council makes on this is likely to be closely scrutinised. He advised that CSI is currently in negotiations with Meridian with re-consenting and the Upper Ohau is prominent in these considerations. He further noted that the Upper Ohau is specifically mentioned in CSI's SFGMP (8.2.13) that has been approved by the Minister.

R Adams spoke to his report noting the controlled fishery proved to be popular with an 89% response rate to the survey of anglers who fished the Upper Ohau which showed the high engagement of anglers with this fishery.

Discussion ensued and staff responded to various queries from Council including concern about whether fishing for spawning fish is sporting behaviour. Others felt happier to allow fishing with half the amount of angling pressure than the previous season and continuation of undertaking surveys. Council recognised that this is a unique fishery with unique opportunities for the angler.

R Adams was thanked for his hard work on this report as well as the contribution from both staff and anglers.

#### 034.2 Designated Waters (8.2)

Council were advised that a Designated Water licence system is being introduced to replace the backcountry licence system for the 2023/24 fishing season. To justify classifying a designated water there needs to be clear rationale and supporting evidence that the angling experience is being negatively affected by excessive angling pressure, and that other management mechanisms (voluntary beats, booking/ballot system etc.) are not suitable for the fishery in question.

General discussion ensued. It was noted that the Upper Ahuriri could be considered but this would need further investigation and surveys to make an informed decision.

## 034.3 2023/24 Anglers Notice Review (8.3)

CE advised that both the Managers and the NZ Council have worked very hard to keep the cost of the proposed licence fee under inflation.

# 034.5 Resident/Non-Resident Definition (8.5)

CE advised this is being addressed for Fish and Game to align its definition of resident and non-resident with the Immigration Act and DOC Taupo.

# 034.6 <u>Draft National Reserves Policy</u> (8.6)

NZ Fish and Game is seeking feedback from regions on its Reserves Policy where it proposes to codify the status quo approach to reserves and provide clarity to all councils on the thresholds and processes associated with reserves. CE advised that CSI reserves stands at near 50% but with the contestable funds on reserves put forward by CSI this will show a reduction to our reserves. After a brief discussion Council noted the draft policy but felt it was not in a position to make any decisions or give a response at this meeting.

#### 034.7 North End Hut Holder Rates Payment for Alexandrina Hut (8.7)

CE advised that Council received notification from North End Hut Holders Assn that they had not received payments towards Lake Alexandrina Hut rates from 2020 through 2023. He confirmed that over that period CSI did not receive any invoices or notification to pay these rates and sought Council's approval to pay this from reserves.

## 034.8 Otuwharekai Collaboration with North Canterbury Fish and Game (8.8)

CE advised that he wishes to collaborate with North Canterbury at an operational level to address the concerns surrounding the sea-run salmon fishery at the headwaters of the Rakaia River. North Canterbury have concerns about Lake Heron whereas CSI are more comfortable in terms of the research it has done. He felt it would be useful for the two regions to collaborate to undertake further detailed research together to understand the potential negative impacts of the current bag limit regulation and other environmental concerns.

## 034.9 OWP Progress (8.9)

CE advised that due to CSI not being able to secure a full complement of staff we are 2,000 hours short. He and staff have worked on prioritising objectives for the current year and have cut significant hours however it is still 600 hours short. He advised that he has engaged two consultancies to undertake work on resource consents/submissions and has also sought support from other F&G regions. He planned to present a revised 2022/23 OWP at the July meeting. He further advised that the 2023/24 OWP includes hours for a staff member that CSI were unsuccessful at gaining approval for so that OWP will need to be amended also.

#### 034.10 Health & Safety (8.10)

CE advised that Councils health and safety policy has been updated to ensure that it meets the requirements of the current state of legislation. The updated policy provides clear guidance to our employees on their responsibilities regarding health and safety in the workplace.

Ngai Tahu engagement was raised, and Council re-iterated its commitment to ensuring this remains high priority for this Council. It was felt it should be a routine agenda item to allow our Ngai Tahu representative to have input.

CE advised that game licences sales are tracking to be on a par with the previous season.
